Subject: Support and Facilitate Nutrition Interventions as per Criteria and to Stop Illegal Use of Nutrition Supplements at District, Facility & Community Level.

In continuation of this Directorate Letter No. 272-348/Nut/DGHS dated 29.06.2022, Letter No. 611/Nut/DGHS dated 28.12.2022, Letter No. 1422/Nut/DGHS dated 29.12.23 & Letter No. 752-92/Nut/DGHS dated 15.10.2024 on the subject cited above; Department of Health Khyber Pakhtunkhwa is implementing various Nutrition Interventions under Provincial Nutrition Cell, DGHS and in partnership with UN-WFP, WHO and UNICEF, Integrated Nutrition Program and BISP Nashonuma Program in all districts of Khyber Pakhtunkhwa, aiming towards reducing burden of malnutrition in vulnerable segment of population (Children and Pregnant and Breastfeeding Women).

It is for your kind information that these Nutrition Supplements are given to the beneficiaries (SAM and MAM Children and PLW) **as per the Standard Protocols and Criteria**. Strick adherence to the Criteria and Protocol is recommended by the Department of Health to avoid the misuse of these Nutrition Supplements and to reach the maximum target population.

It is further intimated that Misuse and selling of Nutrition Supplements are illegal and Department of Health has **ZERO TOLERANCE** for it. Therefore, all concerned District Nutrition Coordinators are hereby directed to be vigilant and not to receive any SNF after the official working Hours, and if any selling is noticed, **report such illegal activities to Local Health and District Administration to curtail such activities and initiate corrective measures against the persons involved under intimation to this office.**

Furthermore, Awareness to the local communities about the proper use of these Nutrition supplements may be initiated in close coordination with the District Health Offices.

Your kind support would enable us to implement the much-needed nutrition intervention for reduction of malnutrition in Khyber Pakhtunkhwa.
