- 2. Bids must be delivered through register courier at the address given before 12:00 hours on 26/06/2024(Wednesday), and shall be opened in the presence of the bidders/their authorized representatives who choose to attend at the address below at 12:30 hours on the same day.
- 3. Separate bids are to be submitted for each item.
- Bearing valid Drugs Sale License under KP Drug Sale Rules 1982(as amended in 2017) for supply of Medicines, Surgical Disposables & Medical Devices etc.
- 5. Any offer received not as per terms & condition of the tender KPPRA Rules will not be entertained.
- 6. Quotation & the offer rate all pages must be signed by the authorized person of the bidder.
- 7. Bids must be accompanied with bids security/earnest money with 2% of the total bids value in the form of call deposit in favor of Medical Superintendent Miangul Abdul Haq Jahanzeb Kidney Hospital Swat.
- 8. The bidders are requested to give their best & final discount price of the quoted items as no negotiation on the price are allowed.
- The bids should be on the letter pad of the bidder duly typed /computerized. No cutting/overwriting will be accepted.
- 10. The bid rates (inclusive of all taxes), will be valid up to 30/06/2025.
- 11. Income tax as per government rules, stamp duty, DPR, Professional Tax, Service tax and sale tax etc. will be deducted at the time of payment subject to the non-availability of deduction certificate.
- 12. The competent authority has the right to reject any or all bids by assigning reason under clause 47 of Khyber Pakhtunkhwa public procurement rules 2014.
- 13. In case the contractor failed to supply the items in the stipulated period, the Hospital Shall purchase the same items from the market on the risk & cost of the contractor.
- 14. All the items will be supplied at Miangul Abdul Haq Jahanzeb Kidney Hospital Swat without any transportation charges.
- 15. The firms shall be bound to accept all the terms & condition of the government/KPPRA and any further condition introduced by the government during the contract period in addition to the terms & conditions mentioned in the tender.
