- 2. Bids must be delivered through register courier at the address given before 11:00 AM on 10/07/2025 Thursday. By hand submitted Quotation will not be considered.
- 3. Tendering open will be held on 10/07/2025 at 11 AM in the MS Office in the presence of Bidders or their authorized representative.
- 4. Separate bids are to be submitted for each item.
- 5. The bids should be on the letter pad of the bidder, only Typed /Computerized. No cutting / Overwriting will be accepted.
- 6. The approved rates will remain effective till 30 June 2026.
- 7. The vendors must be on Active Tax Payer list of FBR having FBR Tax Payer certificate, Sales Tax Certificate.
- 8. Income tax, Sales tax and other applicable taxes will be deducted accordingly.
- 9. Mandatory bid security (CDR) in the name of Medical Superintendent and Type-C hospital City Karak shall be submitted along with the financial bid within sealed envelope.
- 10. The vendor must have valid Drug Sale License/whole sale License and it will be issued by District Drug Inspector.
- 11. The vendor are requested to give their highest possible Discount Rate on maximum retail price for medicines and current market rates for surgical disposables medical Devices, Non Drug items and on prescribed tests/investigations for Sehat Sahulat Card Patients.
- 12. The vendor must have their own Medical Store/Laboratory Unit in front of hospital or within 100 meters of the hospital premises.
- 13. Medicines Pharmacy/Laboratory must be open 24 hours, 07 days a week till 30/06/2026.

- 15. The supplied Drugs shall be of good quality with warranty certificate as per Drugs Act 1976 and which is acceptable to ward consultants/Administration of the hospital.
